\*\*Motion by H Davidson 2<sup>nd</sup> by M Cribelar to approve minutes from 07-13-16 council meeting and 07-27-16 committee meeting.

Upon roll call vote all council members present voted for the motion. (4)

\*\*Motion by M Cribelar, 2<sup>nd</sup> by C Davidson to approve Treasurer's report as presented.

Upon roll call vote all council members present voted for the motion. (4)

\*\*Motion by G Crutchfield 2<sup>nd</sup> by H Davidson to approve July 2016 bills payable in August 2016 in the amount of \$92,445.25.

Motion by C Davidson 2<sup>nd</sup> by H Davidson to approve the cost of removing and stumping the tree at Linn Park, 322 N Elm and 401 N Grant payable to Jones's Tree Service in the amount of \$1600.00.
